

Legionella Awareness & Compliance: ACoP L8

Legionellosis is the collective name given to the pneumonia-like illness caused by legionella bacteria. This includes the most serious legionnaires' disease, as well as the similar but less serious conditions of Pontiac fever and Lochgoilhead fever. Legionnaires' disease is a potentially fatal form of pneumonia and everyone is susceptible to infection. However, some people are at higher risk, including:

- People over 45 years of age
- Smokers and heavy drinkers
- People suffering from chronic respiratory or kidney disease
- Anyone with an impaired immune system

They may be found in purpose-built water systems such as cooling towers, evaporative condensers and whirlpool spas.

Upon completion of this course delegates will have an improved understanding of the consequences of contact with legionella bacteria and the processes required to prevent and/or adequately control the risks in accordance with the new ACoP (L8) regulations..
